- 1. Kids playground-Thompson will check on prices various safe ground covers. Members are to view Shelter Cove playground, Okatie Elementary School and St. Gregory the Great playground surfaces.
- 2. License Plates-Robert will procure estimates for new plates to be given to members as they move into the community. The last time was around \$700.00 for 250 plates.
- 3. Tennis Court-Mr.Keanon took care of the net issue, installed a bench and two score keepers. No soccer is to be played on the court.
- 4. Speed Bumps-Much discussion was held concerning additional speed bumps as requested by members for Mulligan Circle and on Muirfield Drive. The cost is approximately \$1300.00 or more per bump. IV Reading of the Treasurers Report- Thompson noted the electric bill had been posted in one place and needs to be split. Bundy will make the correction.

V Management report-The POA have 5(five) liens and 7(seven) homes in the foreclosure process and 2(two) in bankruptcy. Critter Management has been called to remove a large alligator from the lake.

VI Committee Reports-

VII Old Business- Lake Repair- This may have to be done in the fall. Thompson will determine which area is the most serious need of repair and Bailey to review to finalize the number of feet to be repaired. Bundy will obtain quotes to place a sign on the left side near the guard shack stating," Only one car in Median". Bundy will also source bids to paint the fire hydrants and the curbs at the front entrance. The fire department will give us the paint.
