- 5. Pool Lounge Chairs-Currently getting quotes for new pool lounge chairs, tables and umbrellas. Emailed DDE Outdoor furniture and waiting for response.

- 6. All Care Tree Care-Tree company will be pruning all trees around pool area and taking down water oak tree in far right corner which has a fungus and is decayed. Motion was passed for this work. One tree is diseased on Golf Course property so Bundy Management will send estimate to Shelly at Hallmark Golf.
- 7. Ask Brightview to attend February BOD meeting to go over a few issues we see within community.
- 8. Transformer in front of pump room will be changed and lifted within a few weeks.
- 9. Reserve study was done in 2019. We will revisit in 2023 as we were advised it should be done every 5 years.
